## Release of Liability Agreement

*By signing this document you will waive legal rights, including the right to sue*

I \_\_\_\_\_ am aware that participating in roller hockey may involve dangers and risks including, but not limited to, the danger and risk of collision with other participants or man-made objects (sticks, pucks, boards, and floor), and the risk of serious injury, and/or death and/or property damage.

I freely accept and fully assume all such dangers and risks. In consideration of the **Aliso Niguel Roller Hockey Club, California Street Hockey Association, 949 Roller Hockey Center, Cities, City of Laguna Hills, Saddleback Valley Unified School District, Capistrano Unified School District, other School Districts** and the **Interscholastic Hockey Federation**, member leagues, League managers, sponsors, rink owners, landlords, their directors, officers, employees, agents, representatives, coaches and any volunteers associated with the roller hockey program (hereinafter referred to as "Releasees") permitting my participation in the roller hockey program, I further agree as follows:

1. To abide by the rules and procedures and agree to wear required protective gear while participating in all practices and league games;
2. To waive any and all claims that may have against the Releasees;
3. To release Releasees from any and all liability for any loss, damage, injury or expense that I may suffer as a result of my participation in the program due to any cause whatsoever, including any negligence of the Releasees or otherwise;
4. To hold harmless and indemnify the Releasees from any and all liability for any property damage or personal injury to any third party, resulting from my participation in the program; and
5. That this release of liability shall be effective and binding upon my heirs, next of kin, executors, administrators, and assigns in the event of participant's death;
6. I warrant that I am in good physical health and I have no physical condition that may affect my performance or my ability to play the sport or that may create a greater risk of injury; and
7. I hereby understand that currently the club sport is neither a school sponsored activity nor a school sport. That currently the participant will not receive physical education credit for participation. There will be no school or district supervision or school or district transportation.

**I have read and understood this release of liability prior to signing it, and I am aware that by signing this release of liability I am waiving certain legal rights which I or my heirs, executors, administrators and assigns may have against the Releasees.**
